ORDER

Based on the guidelines issued by the Government of India in connection with the strategic launching of Jal Jeevan Mission (JJM), the Government of Kerala have accorded sanction for JJM vide G O dated, 08.06.2020. The state has ordered stringent financial control measures owing to the outbreak of Covid – 19 pandemic and consequent lock-down, it necessitated the shifting the posts of LD/UD Clerks and transfer and posting LD/UD Clerks to needed places for speedy implementation of Jal Jeevan Mission.

Vide read above the controlling officers from various offices of Kerala Water Authority also reported that the shortage of clerical staff in Revenue Units badly affects the proper functioning of Section offices. Also shortage of staff affects the timely preparation and submission of monthly Accounts, processing of establishment files, O&M and work bills, preparation and payments. etc.

For strengthening the Section Offices of Kerala Water Authority to ensure the prompt timely services to consumers the following post shifting and attachment of Lower Division Clerks and Upper Division are ordered with immediate effect.
