S. R. O. No. 302/2017.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Second Amendment) Rules, 2017.

(2) They shall be deemed to have come into force on the 1st day of July, 2014.

2. *Amendment of the Rules.*—In the Kerala Service Rules,—

(a) in Part I,

(i) in rule 90 A, in clause (a), for the letters and figures “Rs. 22360”, “Rs. 7826” and “Rs. 5220”, the letters and figures, “Rs. 42500”, “Rs. 14875” and “Rs. 9915” shall, respectively be substituted;

(ii) in rule 93, in the Exception to clause (ii), for the words, letters, figures and brackets “does not exceed Rs. 18740 in the revised scale of pay ordered in G. O. (P) No. 85/2011/Fin. dated 26th February, 2011”, the words, letters, figures and brackets “does not exceed Rs. 35700 in the revised scale of pay ordered in G. O. (P) No. 7/2016/Fin. dated 20th January, 2016” shall be substituted;

(iii) in rule 103, in clause (b), for the letters and figures “Rs. 14620”, the letters and figures “Rs. 27800” shall be substituted;

(b) in Appendix VII, under the heading “Section II—Special Casual Leave”, in clause (i) of rule 1, for the letters and figures “Rs. 16180”, the letters and figures “Rs. 30700” shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 07/2016/Fin. dated 20th January, 2016 the Government have issued orders revising the pay and allowances of State Government employees and teachers with effect from 1st July, 2014. Consequential modifications to the monetary limits specified under Rules 90 A, 93, 103 and Appendix VII of Part I of the Kerala Service Rules have to be made with effect from 1st July, 2014. Therefore, the Government have decided to amend the Kerala Service Rules suitably.
