ORDER

The Hon. High Court of Kerala vide judgments read above directed the Kerala Water Authority to follow the principle in the seniority list of 01.11.2000 in making further promotions. Any further temporary promotions should be only on the principle of the seniority list of 01.11.2000. In making such promotions, definitely Rule 27(a) and (c) of the KS&SSR have to be followed scrupulously. Hence in compliance of order a seniority list has been prepared and published vide reference read 6 above. At present eight post of Assistant Engineers are lying vacant which are earmarked for promotion, ie., 8 Nos. in Diploma Quota.

In the above circumstances, with the clarification from the legal wing of Kerala Water Authority, the under mentioned eight senior most D'Man Grade - I are here by temporarily promoted to the post of Assistant Engineer subject to the conditions stated below in the scale of pay of Rs.40800-85000 and posted to the place noted against their names with immediate effect.

1. The promotions shall be purely provisional as per prevailing rules in KS & SSR with terms and conditions stipulated in KS & SSR Part II Rule 5 Note 3 and of Rule 27, KS & SSR.
2. The promotions are subject to further directions of Hon'ble High Court and Govt. orders.

The promotion shall be provisional subject to such conditions.

Before leaving the present offices all the officers promoted should hand over their charges along with files and documents including `Memorandum of Works` (soft copy to be emailed) are to be submitted to the controlling officers and controlling officer should ensure that none of the incumbents are relieved without proper handing over of charges and submission of `Memorandum of Works` to strengthen institutional memory and professional business continuity. The places of posting are liable to be changed during the General Transfer 2021.
