#### Order

In judgment dated, 12.10.2018 in vide read (3) the Hon'ble High Court of Kerala has observed amendment vide read (2) and affirmed that the amendment to Rule 12 of the 2011 Rules (Kerala Water Authority (Administrative, Ministerial and Last Grade) Service Rules 2011) through the 2016 Rules is curative and should be operated retrospectively from the date on which 2011 Rules came in to force. Based on the judgment, the promotion of Head Clerks in accordance with their seniority vide read 4 above.

The following provisional promotion of Head Clerks as Junior Superintendents in the scale of pay of Rs. 30800 - 69800 are hereby ordered with immediate effect. .

The promotion is subjected to the direction of the Hon'ble High Court of Kerala and the final decisions by the Government. **The place of posting of promotees shall be subject to the changes as per general transfer norms in accordance with the circular read 5 above after lifting of Code of Conduct declared by the Election Commission. There fore the incumbents in this orders shall not have any claim over the place to which they are now promoted and posted.** Before admitting the promotee for duty, Controlling Officer shall obtain an undertaking as appended herewith from the incumbent and the same shall be pasted in the Service Book.
