ORDER

As per Government Order read 2nd above, 5% of the vacancies of Lower Division Clerks shall be reserved for the qualified service personnel working in any of the lower categories included under Kerala Water Authority (Administrative, Ministerial and Last Grade), Service Rules, 2011 or KWA Public Health Engineering Services Rules / KWA Technical Special Rules based on their seniority in the lower post for by transfer appointment at the level of KWA. Accordingly the final seniority list published as per 4th read above and the same was modified as per proceedings read 5th above.
