As the lock down period in connection with the Covid 19 pandemic is not completely withdrawn in the State, Government are now pleased to extend the adhoc arrangement for paperless monthly salary claims through SPARK (including aided institutions) permitted as per GO read second above for the month 08/2020 also, in continuation of the GO read 5th paper above subject to the conditions mentioned in GO read second paper above.

- 2) These directions are not applicable to the Departments which are exclusively permitted to use paper less bill system for monthly salary claims as per GO read first and sixth paper above.
- 3) Government are also pleased to permit the DDOs of all departments (including aided institutions) to follow the adhoc arrangement of paperless bill system for the bills for Festival advance, Festival allowance & Bonus claims of employees with PEN, sanctioned vide the G.Os read as 7th and 8th papers above and which are SPARK generated. Such bills of employees with PEN, downloaded from SPARK are to be saved with file name "DDO code+Bonus/Fest Adv/Fest Allow" and to be forwarded to treasury concerned via e-mail, after e submitting the same using DSC, without fail.
