S. R. O. No. 369/2016.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules, further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Second Amendment) Rules, 2016.

(2) They shall be deemed to have come into force on the 18th day of August, 2014.

2. *Amendment of the Rules.*—In Part I of the Kerala Service Rules, in APPENDIX VII, under the heading “SECTION II—SPECIAL CASUAL LEAVE”, after rule 20, the following rule shall be inserted, namely :—

“20 A. An officer may be granted Special Casual Leave for a period up to 15 days in a calendar year for the treatment of his children, below 18 years of age, who undergo Chemotherapy for the treatment of Cancer, Dialysis for the treatment of Kidney and affected with HIV, subject to the same conditions as specified under Rule 20”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O. (P) No. 341/2014/Fin. dated 18th August, 2014, Government have sanctioned special casual leave for a period up to 15 days in a calendar year to the officers (father or mother) having children below 18 years of age who undergo Chemotherapy for the treatment of Cancer, Dialysis for the treatment of Kidney and affected with HIV on the basis of the 6th Report dated 4th February, 2014 of the Committee on the Welfare of Women, Children and Physically Handicapped. In order to give statutory validity to the said Government Order, Government have decided to amend Section II of Appendix VII of Part I of the Kerala Service Rules.

The notification is intended to achieve the above object.
