**ORDER**

As per Government Order read as 1<sup>st</sup> above, Government have issued orders prescribing revised monthly/quarterly ceiling of Travelling Allowances for official journeys of officers. As per GO read 2<sup>nd</sup> above it was ordered that, in cases where TA bills exceeds the monthly/quarterly ceilings, such claims should invariably be supported with original train/flight tickets for admitting such claims.

Now it is come to the notice of the Government that certain ambiguities have risen regarding the extent of applicability of the said order. Therefore Government is pleased to revoke the orders issued vide reference 2<sup>nd</sup> above and issue further orders as follows.

Any employee whose TA bill exceeds monthly/quarterly ceiling, shall submit the originals of train ticket /copy of flight ticket attached to the TA bill, for admitting such claims. This requirement would apply to all those employees who have now been permanently exempted from TA ceiling or given one time exemption.

All other instructions mentioned in Government Order read 1<sup>st</sup> will remain unchanged.
