ORDER

In the Government Order read as second paper above orders have been issued enhancing the number of days of maternity leave admissible to female officers under Rule 100 Part I, KSRs to 180 days. By this female officers proceeding on Maternity Leave gets leave upto 180 days. But corresponding changes have not been made to the Note 5 ibid enabling female recruits through Public Service Commission also the benefits of the enhanced period.

Government after detailed examination are pleased to enhance the limit of 135 days in Note 5 to Rule 100 Part I KSRs to 180 days enabling fresh female recruits also the benefit of the enhancement subject to the other condition below the Note. Necessary amendment to the rules in KSRs will be issued separately.
