ORDER

The Honourable High Court of Kerala vide judgments read above have directed Kerala Water Authority to follow the principle in the seniority list of 01.11.2000 in making further promotions. In making such promotions, Rule 27(a) and (c) of KS&SSR have to be followed scrupulously. Hence in compliance of the order a seniority list has been prepared and published vide reference read 6 above. At present five posts of Assistant Engineers are lying vacant in Certificate Quota. As per letter read 10 above, the Government has given permission to promote the existing vacancy from the approved seniority list without affecting the election duties. The under mentioned promotees are not assigned for election duties till date.

In the above circumstances, with the concurrence of the legal cell of Kerala Water Authority, the under mentioned five senior most Draughtsman Grade-I are here by temporarily promoted to the post of Assistant Engineer subject to the conditions stated below in the scale of pay of Rs.40800-85000 and posted to the place noted against their names with immediate effect.

- 1. The promotions are purely provisional as per prevailing rules in KS & SSR with terms and conditions stipulated in KS & SSR Part II Rule 5 Note 3 and of Rule 27, KS & SSR.
- 2. The promotions are subject to further directions of Hon'ble High Court and Govt.
