**S. R. O. No. 431/2018.**—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala, hereby make the following rules further to amend the Kerala Service Rules, namely:—

PRINTED AND PUBLISHED BY THE SUPERINTENDENT OF GOVERNMENT PRESSES  
AT THE GOVERNMENT CENTRAL PRESS, THIRUVANANTHAPURAM, 2018.

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Nineth Amendment) Rules, 2018.

(2) They shall be deemed to have come into force on the 1st day of January, 1992.

2. *Amendment of the Rules.*—In Part III of the Kerala Service Rules,—

(1) after rule 14J, the following rule shall be inserted, namely:—

“14K. Service in the post of Temporary Munsiff-Magistrate shall be reckoned as qualifying service for pension.”

(2) in rule 62, after Note 6, the following Note shall be inserted, namely:—

“*Note 7.*—The pay drawn by an Officer while appointed as temporary Munsiff-Magistrate under rule 9 of the Kerala Judicial Service Rules, 1991 shall not be treated as emoluments for pension. In such cases the pay he/she would have drawn for the post in parent department/previous post under ministerial cadre, had he/she not been on temporary service, shall be treated as emoluments for pension and pensionary benefits.”

(3) in rule 63, after Note 10, the following Note shall be inserted, namely:—

“*Note 11.*—The pay drawn by an Officer while appointed as Temporary Munsiff-Magistrate under rule 9 of Kerala Judicial Service Rules, 1991 shall not be treated as emoluments for pension. In such cases the pay he/she would have drawn for the post in the parent department/previous post under ministerial cadre, had he/she not been on temporary service, shall be treated as emoluments for pension and pensionary benefits.”

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 23/2016/Fin. dated 14th February 2016, the Government have decided that the pay drawn by an Officer while appointed as Temporary Munsiff-Magistrate under rule 9 of Kerala Judicial Service Rules, 1991 shall not be treated as emoluments for pension. In such cases the pay he/she would have drawn for the post in parent department/previous post under ministerial cadre, had he/she not been on temporary service, shall be treated as emoluments for pension and pensionary benefits. But the service in the post of Temporary Munsiff-Magistrate shall be reckoned as qualifying service for pension. It has also been decided that event hough the order shall have retrospective effect but cases already settled shall not be reopened. Since it has been decided that the Government Order shall have retrospective effect, and the Temporary Munsiff-Magistrates were appointed in accordance with rule 9 of Kerala Judicial Service Rules, 1991, the date of effect is given as the date of effect of the Kerala Judicial Services Rules, 1991 ie. with effect from 1st January, 1992. In order to give statutory validity to the above decision, suitable amendments have to be made to Part III of the Kerala Service Rules.
