### ORDER

As per the Government Order read 1<sup>st</sup> above, it has been ordered that, physically handicapped employees are eligible for Conveyance Allowance during the time of Special Casual Leave, since Special Casual Leave is duty for all purposes, just like ordinary Casual Leave. Several doubts have been raised as to whether Special Casual Leave can be treated as ordinary casual leave as ordered in the above G.O.

2. As per the G.O. read 2<sup>nd</sup> above, it has been clarified that the periods of absence due to Special Casual Leave under Section II, Appendix VII, Part I, the Kerala Service Rules, will not be reckoned as duty for the purpose of accrual of earned leave. More over, Special Casual leave is not included in the definition of Duty under Rule 2(6) Part I the KS&SSRs and Rule 12 (7) Part I the KSRs.

3. In these circumstances, Government have examined the matter in detail and decided to exclude the last portion of the G.O. read as 1<sup>st</sup> above ie "since Special Casual Leave is duty for all purposes, just like ordinary casual leave". The G.O. read as 1<sup>st</sup> above stands modified to the above extent and all other conditions in the G.O. remain unaltered.
