S. R. O. No. 153/2019.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala, hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Fourth Amendment) Rules, 2019.

(2) In rule 2,—

(a) sub-rule (1) shall be deemed to have come into force on the 1st day of July, 2004;

(b) sub-rule (2) shall be deemed to have come into force on the 1st day of July, 2014.

2. *Amendment of the Rules.*—In Part III of the Kerala Service Rules, in rule 63,—

(1) in 'Note 10', the following sentences shall be added at the end, namely:—

“While revising pension for those who have the eligibility for full pension, if the pension so arrived at is less than fifty percent of the minimum of the revised scale of pay of the post from which he/she retired, fifty percent of the minimum of the revised scale of pay shall be ensured. For those, who are not eligible for full pension, the proportion of full pension based on the length of qualifying service shall be ensured.”;

(2) after 'Note 10', the following note shall be inserted, namely:—

“*Note 10A.*—The benefit contemplated as per 'Note 10' above shall be extended to those employees in respect of whom pre-revised pay forms part of average emoluments consequent on availing Leave Without Allowance upto four months during the last ten months of service except those who avail Leave Without Allowance under Appendix XII A, XII B and XII C”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 150/2015/Fin. dated 24th April, 2015, the Government have ordered that the pensioners whose average emoluments for the last ten months before retirement are spread over to pre-revised and revised scale of pay and who have the eligibility for full pension, if the pension calculated at the time of retirement is less than fifty percent of the minimum of the revised scale of pay of the post from which they retired, fifty percent of the minimum of the revised scale of pay shall be ensured and that for the retirees who are not eligible for full pension, the proportion of the full pension based on the length of qualifying service shall be ensured. As per G. O. (P) No. 278/2015/Fin. dated 10th July, 2015, the Government have clarified that the date of effect of the above said Government Order dated 24th April, 2015 is from the date of effect of the 8th Pay Revision, i.e, from 1st July, 2004.

As per G. O. (P) No. 56/2018/Fin. dated 3rd April, 2018, it has been ordered that the benefit contemplated as per 'Note 10' below rule 63 of Part III of the Kerala Service Rules shall be extended to an employee whose pre-revised pay forms part of average emoluments consequent on availing Leave Without Allowance up to four months during the last ten months of service except those who avail Leave Without Allowance under Appendix XII A, XII B and XII C w.e.f. 1st July, 2014.

To give statutory validity to the above said Government Orders, the Government have decided to amend Part III of the Kerala Service Rules suitably.

The notification is intended to achieve the above object.
