S. R. O. No. 460/2018.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules, further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Tenth Amendment) Rules, 2018.

(2) They shall be deemed to have come into force on the 7th day of March, 2017.

2. *Amendment of the Rules.*—In Part I of the Kerala Service Rules, in Appendix IV, for the existing Schedule to the note under Class VI, the following Schedule shall be substituted, namely:—
