Kerala Water Authority is a unique state wide public sector establishment in drinking water sector with the aid of government. Jal Jeevan Mission (JJM) has been launched by Government of India which aims at providing Functional Household Tap Connection (FHTC) to every rural household by 2024, in collaboration with State Governments on a 50:50 cost sharing basis.
