AMENDMENT TO THE RULES FOR THE ALLOTMENT AND OCCUPATION OF  
GOVERNMENT SERVANTS' QUARTERS IN KERALA 2006

1. These Rules may be called the Amendment Rules for the allotment and occupation of Government Servants' Quarters in Kerala, 2006.

2. It shall come into force at once.

3. Amendment of the Rules issued under GO(MS)No.11/2006/PWD dated 28.02.2006.

1) In rule 9, after clause (viii) the following clauses shall be inserted, namely:-

- "(ix) 50% of the quarters shall be reserved for allotment to women staff
- (x) Government servants who are from distant places".

2) (i) in rule 10, for the figure and words "75Nos." the figure and words "200" Nos." shall be substituted;

(ii) After the words "Deputy Speaker" the words "Leader of Opposition" shall be inserted;

(iii) for the existing clause (ii), the following clauses shall be substituted namely-

"(ii) Members of the personal staff including Government employees shall vacate the quarters allotted to them within one month positively from the date on which they cease to be the member of personal staff.

(ii)(a) Notwithstanding anything contained in these Rules, the Government employees who were ceased to be members of personal staff, but continued in the Government Quarters allotted to them under clause (ii) of Rule 10 as it stood before this amendment, shall vacate the quarters within one month positively from the date of this amendment, if they have not been allotted the Government quarters under rule 6 or 32."

3) (i) in rule 16 (i), for the words "not exceeding six months" the word "not exceeding three months" shall be substituted.

(ii) In rule 16(ii), for the words "not exceeding six months" the words "not exceeding three months" shall be substituted.

(iii) In rule 16 (iv), for the words "six months" the words "three months" shall be substituted.

(iv) In rule 16 (iv) (a), for the words "six months" the words "three months" shall be substituted.

(v) In rule 16(v) for the words "six months" the words "three months" shall be substituted.

(vi) In rule (vi), for the words "two years" the words "three months" shall be substituted.

4) In rule 27,

(i) The sentence "This period may be extended up to six months in exceptional cases with the permission of the Executive Engineer in writing" shall be omitted.

(ii) For the words "exceed six months" the words "exceed three months" shall be substituted.
