RULES

- 1. Short title and commencement.—(1) These rules may be called the Kerala Service (Third Amendment) Rules, 2019.
- (2) They shall be deemed to have come into force on the 29th day of August, 2016.
- 2. Amendment of the Rules.—In Part III of the Kerala Service Rules, in rule 143, after instruction 1, the following instruction shall be inserted, namely:—
- "1A. Details as to whether the appointment is in merit quota or in reservation quota shall be entered in the Service Book while entering details of advice memo and appointment order".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G.O. (P) No. 125/2016/Fin. dated 29th August, 2016, the Government have ordered that while entering the details of advice memo and appointment order, details as to whether the appointment is in merit quota or in reservation quota shall be entered in the Service Book. In order to give statutory validity to the above said Government Order, suitable amendment has to be made in Part III of the Kerala Service Rules.

The notification is intended to achieve the above object.
