Order

Lack of skilled personnel in the area of Information Technology and Energy Management is creating dependency on external agencies in the implementation of e-governance projects in Kerala Water Authority. To address this, as per the resolution no.10351 of the 386th meeting, The Authority resolved to form a Virtual IT Cadre in KWA. For the smooth functioning of the Virtual IT Cadre and for the support of IT Unit following incumbents were appointed to IT Unit on working arrangement for one year and the same was being extended every year.

Vide letter read above all the working arrangements in Kerala Water Authority were cancelled and the controlling officers were directed to relieve the incumbents on working arrangements to their original station. However, it is seen that the service of the employees in Virtual IT Cadre is essential for the smooth functioning of IT Unit.

Kerala Water Authority is one of the biggest consumer of electricity in the state having more than 260 HT Connections at present. So proper energy audit and policy making on energy conservation are essential for Kerala Water Authority. So it is essential to strengthen the Electrical Wing of Head office.
